1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending *PoochiePlay, LLC*.
2. I further understand and agree that in admitting my dog(s) to *Poochie Play, LLC*, *Poochie Play, LLC's* staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that it is standard procedure that all daycare/boarding dogs are current with a flea and tick preventative, and furthermore dogs who are found to have fleas or ticks will be bathed at the owners expense.
4. I further understand and agree that *Poochie Play, LLC* and their staff, interns and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s)/dog(s) attendance and participation at *Poochie Play, LLC*.
5. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare. Since the dogs are intermingling, there is a chance that your dog may contract a contagious condition such as kennel cough. Any problems that develop with my dog(s) will be treated as deemed best by staff, interns, volunteers or *Poochie Play, LLC*, at their sole discretion. A veterinarian will be contacted if deemed necessary, and I assume full financial responsibility for any and all expenses involved.
6. I further understand by allowing my dog(s) to participate in services offered by *Poochie Play, LLC* I hereby agree to allow *Poochie Play, LLC* to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
7. I further understand my dog(s) must be licensed in the town in which he/she lives.
8. I further understand that if my dog(s) is/are not picked up on time or by a date specified in a separate agreement, I hereby authorize *Poochie Play, LLC* to take whatever action is deemed necessary for the continuing care of my dog(s). I will pay *Poochie Play, LLC* the cost of any such continuing care upon demand by *Poochie Play, LLC*. I understand if I do not pick up my animal, *Poochie Play, LLC* will proceed according to the guidelines provided by the State of CT Section 49-70.
